

Information regarding the scholarship grants starting with the academic year

2019-2020

The study places shall be assigned within accredited education programs, conducted in Romanian language, for the full-time learning.

The stages of specialization (months-scholarship) may also be assigned for accredited study programs conducted in a international language, for the full-time learning.

1. Eligibility criteria:

- a) They do not hold Romanian citizenship did not request or did not achieve any form of protection or they are not stateless whose staying in Romania is officially recognized in keeping with the law;
- b) They are not members of the diplomatic corps or family members of the diplomatic corps accredited in Romania;
- c) They were nominated, through diplomatic channels, by authorized partners;
- d) They did not benefit from a scholarship granted by the Romanian state for the same study cycle;
- e) They present study documents issued by accredited/recognised education institutions;
- f) They present study documents highlighting that the studies previously attained and their duration allow the enrolment in Romania for the required field and level of study;
- g) They have good results regarding their education process, namely an average of minimum 7 (seven) corresponding to the grading system in Romania or the „Good” mark, if applicable;
- h) Until the 31st of December of the year they were nominated, they are not above 35 years old – for Bachelor and Master studies, and above 45 years old, respectively, for PhD studies or for post-university studies, including for the Health field.

2. Application file:

The application file shall be submitted in double exemplary (1 exemplary comprising the photocopy of the documents and their certified translations, and one exemplary comprising the simple photocopy of all the documents comprised in the first file). The certified translations shall be submitted in Romanian, English or French.

A. Bachelor studies application file:

- a) Application form for scholarship in Romania filled in for all its rubrics, in two originals, alongside 2 recent colour photographs.
- b) Birth Certificate – photocopy and certified translation;
- c) Document attesting the permanent residence – photocopy and certified translation;

- d) Passport, valid for at least 6 month starting from the beginning of the requested study programme – photocopy of the first 2 pages;
- e) Identity card – photocopy and certified translation;
- f) Document certifying the name change (if applicable) – photocopy and certified translation;
- g) Certificate attesting the graduation of highschool or its equivalent, authenticated by the competent authorities of the issuing country – photocopy and certified translation;
- h) The proof certifying the passing of the highschool graduation exam, for the graduates of the current year – photocopy and certified translation;
- i) Academic Transcripts/Diploma Supplement for the attained studies, authenticated by the authorities in the issuing country – copies and certified translations;
- j) Applicant's declaration that he/she did not benefit from scholarship granted by the Romanian state for the requested academic level;
- k) Certificate of graduation for Romanian language preparatory year or the certificate of language proficiency, as the case may be;
- l) The medical certificate (in international language) certifying the fact that the person who is to be enrolled for studies does not suffer from contagious diseases or from other impairments that are incompatible with the future profession;
- m) CV in English, French or Romanian (max. 2-3 pages).

B. Master studies application file:

- a) Application form for scholarship in Romania filled in for all its rubrics, in two originals, alongside 2 recent colour photographs.
- b) Birth Certificate – photocopy and certified translation;
- c) Document attesting the permanent residence – photocopy and certified translation;
- d) Passport, valid for at least 6 month starting from the beginning of the requested study programme – photocopy of the first 2 pages;
- e) Identity card – photocopy and certified translation;
- f) Document certifying the name change (if applicable) – photocopy and certified translation;
- g) Certificate attesting the graduation of highschool or its equivalent, authenticated by the competent authorities of the issuing country – photocopy and certified translation;
- h) Academic Transcripts/Diploma Supplement for the attained studies, authenticated by the authorities in the issuing country – copies and certified translations;

- i) Bachelor diploma or its equivalent, authenticated by the competent authorities of the issuing country – photocopy and certified translation;
- j) The proof certifying the passing of the bachelor graduation exam, for the graduates of the current year – photocopy and certified translation;
- k) Academic Transcripts/Diploma Supplement for the attained studies, authenticated by the authorities in the issuing country – copies and certified translations;
- l) Applicant's declaration that he/she did not benefit from scholarship granted by the Romanian state for the requested academic level;
- m) Certificate of graduation for Romanian language preparatory year or the certificate of language proficiency, as the case may be;
- n) The medical certificate (In international language) certifying the fact that the person who is to be enrolled for studies does not suffer from contagious diseases or from other impairments that are incompatible with the future profession;
- o) CV in English, French or Romanian (max. 2-3 pages).

C. Doctoral studies application file – the enrolment is conditional upon the submission of the agreement in principle of a scientific coordinator and upon the promotion of the admission exam;

- b) Birth Certificate – photocopy and certified translation;
- c) Document attesting the permanent residence – photocopy and certified translation;
- d) Passport, valid for at least 6 month starting from the beginning of the requested study programme – photocopy of the first 2 pages;
- e) Identity card – photocopy and certified translation;
- f) Document certifying the name change (if applicable) – photocopy and certified translation;
- g) Bachelor diploma and Masters diploma or their equivalent, authenticated by the competent authorities of the issuing country – photocopy and certified translation;
- h) The proof certifying the passing of the masters graduation exam, for the graduates of the current year – photocopy and certified translation;
- i) Academic Transcripts/Diploma Supplement for the attained studies, authenticated by the authorities in the issuing country – copies and certified translations;
- j) Applicant's declaration that he/she did not benefit from scholarship granted by the

Romanian state for the requested academic level;

- k) Certificate of graduation for Romanian language preparatory year or the certificate of language proficiency, as the case may be;
- l) The medical certificate (in international language) certifying the fact that the person who is to be enrolled for studies does not suffer from contagious diseases or from other impairments that are incompatible with the future profession;
- m) CV in English, French or Romanian (max. 2-3 pages).

D. Application file for post-university studies:

- a) Application form for scholarship in Romania filled in for all its rubrics, in two originals, alongside 2 recent colour photographs.
- b) Birth Certificate – photocopy and certified translation;
- c) Document attesting the permanent residence – photocopy and certified translation;
- d) Passport, valid for at least 6 month starting from the beginning of the requested study programme – photocopy of the first 2 pages;
- e) Identity card – photocopy and certified translation;
- f) Document certifying the name change (if applicable) – photocopy and certified translation;
- g) Highschool and/or Bachelor and/or Master's and/or PhD diploma or their equivalent, authenticated by the competent authorities of the issuing country – photocopy and certified translation;
- h) The proof certifying the enrolment at university or post-university studies in the country of origin – photocopy and certified translation;
- i) The proof certifying the passing of the PhD exam, for the graduates of the current year – photocopy and certified translation;
- j) The medical certificate (in international language) certifying the fact that the person who is to be enrolled for studies does not suffer from contagious diseases or from other impairments that are incompatible with the future profession;
- k) CV in English, French or Romanian (max. 2-3 pages);
- l) Planning of the research activity during the post-university studies in Romanian, English or French languages.
